The following was received from Jennifer U., Archivist & Conference Specialist (Spanish) and Suzanne M., Associate Director – Conference 01-15-2025

What is the WSC? Why is it held? "World Service Conference (WSC) Al-Anon's annual business meeting, which is attended by all Delegates from the World Service Conference Structure, representatives from other countries, members of the Board of Trustees and Executive Committee, voting members of the World Service Office (WSO) administrative Staff, and other WSO personnel. The Conference provides guidance to the WSO on service matters that are brought to its attention." Al-Anon/Alateen Service Manual (P-24/27), "World Service Handbook section page 143

"The World Service Conference makes the group conscience available and effective for all AlAnon. It is the practical means by which the group conscience can speak; it is the voice of world Al-Anon and the guarantee that our world services shall continue to carry on under all conditions."

"The Conference protects Al-Anon and Alateen against a service breakdown; it makes for unity and enables our fellowship to act as a whole upon important matters. This makes it the principal guarantor of Al-Anon and Alateen's harmony and survival." **Al-Anon/Alateen Service Manual (P-24/27), "World Service Handbook" section page 164**

Who are the WSC Attendees? Sixty-eight (68) Delegates from the US (including Puerto Rico), Bermuda, Canada, and the Global Electronic Area attend the WSC with voice and vote. The

Board of Trustees, the Executive Committee, and the World Service Conference WSO Staff also have voice and vote. International Representatives are chosen and financially sponsored by their structures and have voice, but no vote. The Director of Finance & Operations and the Chairperson of the Executive Page 2 Committee for Real Property Management attend general sessions with voice limited to their role, but they have no vote.

It may be necessary for certain non-voting participants to attend the WSC at the discretion of the WSO. Seating of these Conference participants and observers is subject to the approval of the members of the CLT who are furnished with names, job descriptions, and rationale. Following the Board's approval of the Seating Motion, all Conference members will also vote on the Seating Motion prior to the Conference convening.

World Service Conference Attendees – the following was received from Jennifer U., Archivist & Conference Specialist (Spanish) 01-17-2025 – more condensed version of voting and non-voting members. There are 92 voting members per reference from Suzanne M. 01-25-2025 regarding an Affirmation Process Survey results.

Voting members of the World Service Conference include:

- One elected Delegate from each Assembly Area in the WSC Structure
- The Board of Trustees
- The Executive Committee
- Voting members of the World Service Office administrative Staff.

Non-voting members of the World Service Conference include:

- The Director of Finance & Operations
- The Executive Committee for Real Property Management Chairperson
- International Representatives from other structures
- Select Staff members who attend as observers

Also note that we ask that members and groups refrain from mailing boxes, packages, and large envelopes to the hotel, as the hotel will charge the WSO for acceptance and storage of these items. Conference Mail

We ask that you consider and share this message from the WSO:

Regarding the use of CAL quotations in/on love gifts-we recognize that the World Service Conference has established a Copyright Policy. However, we also acknowledge that consistently putting this policy into practice regarding love gifts is not only challenging and time-consuming to the members creating love gifts, but also to Staff involved with the reprint approval process. We are also aware that reprint requests submitted for love gifts are few and far between, and yet CAL quotations continue to be included without permission on/in many love gifts.

Therefore, rather than strong insistence on written reprint permission for love gifts, which could possibly bring more work to Staff than it is able to accommodate, the WSO is providing the following guidance to be considered in the creation of love gifts.

- 1. Consider using items in public domain, such as one of the 16 slogans, the Serenity Prayer, or Just for Today (M-12).
- 2. If you do quote from CAL:
- o Distribute the love gift only within the fellowship o Keep the quotation brief-from a few words to a couple sentences

o Quote accurately-keep original wording without alterations o Include the title and page number the quote is from

o Limit it to one-time use Page 4

I was given the opportunity to participate in a "Opportunity to Serve" survey as a delegate. It was noted that one of the options was to opt out and that not all Delegates will be assigned to serve right away as other opportunities to serve may arise during the year. The options available were:
